The Government of Uganda, through the Ministry of Works and Transport (MoWT) has received financing from the African Development Bank toward the cost of the Kampala-Jinja Expressway Public Private Partnership (PPP) Project, and intends to apply part of the agreed amount for this loan to payments under the contract for selection of the Team Leader/PPP Specialist and Highway Engineer

The services included under this project are:

1. The **Team Leader/ PPP Specialist** will lead the PPP Implementation Unit and oversee the preparation and execution of the Kampala-Jinja Expressway and subsequent PPP projects. The Team Leader will be responsible for working with different stakeholders on the development, implementation, and marketing of the Kampala-Jinja Expressway. 2. The **Highway Engineer** will lead all facets of highway engineering on the Kampala- Jinja Expressway PPP Project and subsequent PPP projects, including alignments and ancillary features, pavements, drainage, and utility relocations. The incumbent will be able to give advice on all highway related aspects in the contract, including operations and maintenance as well as during the design, construction, and operation of the project. The duration of the assignment is **thirty-six (36) months** for each position.
